The CBD Women's Caucus (CBD-WC) is an independent, self-organised, permanent and sustainable entity under the scope of the Convention on Biological Diversity (CBD) guided by a framework of collective ownership, shared leadership, and collaborative action, enabling the Caucus to drive positive change for gender justice and the empowerment of women and girls in all their diversity in biodiversity-related decision-making spaces.
